#### **Dubai Genome Program Workshop**




#### **Informal Social Gathering**


# Prof. Luai Ahmed Being Elected as a Fellow of the Faculty of Public Health of the Royal Colleges of Physicians, UK

### Abu Dhabi University (ADU) Public Health Program Advisory Board








#### Participation in the ICOH 2024 conference

The 34th International Congress on Occupational Health, the biggest and most respected triennial conference in occupational health, was held between 28 April and 3 May 2024 - in in Marrakesh, Morocco. The conference hosted attendees from all over the world, discussing various topics of occupational health in oral and poster presentations. Dr. Balázs Ádám held an oral presentation on occupational exposures to carcinogens among migrant workers in the United Arab Emirates, which attracted considerable attention, being the first study of its kind and consequently providing gap-filling information on this topic in the Middle East. His PhD student, Moustafa Sherif, prepared a poster presentation for the conference that discussed the genotoxicity of occupational pesticide exposures among agricultural workers in Arab countries, the first systematic review about this major occupational health issue in the region. The poster presentation received the ICOH award, which is а considerable professional In acknowledgment of this work. addition to the successful presentations, the conference provided unique opportunity for networking with the most renounced occupational health professional worldwide.



Just before the conference, the 13th Meeting of the Global Network of WHO Collaborating Centres for Occupational Health took place between 25-26 April 2024 in Marrakesh. Dr. Balázs Ádám was officially invited to participate in this very important event of the World Health Organization, where the current situation of occupational health at the WHO, as well as the most important tasks and challenges of this field were discussed. The need to strengthen efforts to protect the workforce from the harmful effects of climate change as well as of climate change adaptation and mitigation was highlighted. In this regard, Dr. Balázs Ádám suggested formulating a statement on climate change and workplace health for the upcoming 29th Conference of the Parties (COP29), which he was tasked to coordinate.




### Congratulations to Prof. Mohamud Sheek-Hussein on His Appointment as Adjunct Professor at IPH

### Interview with Dr. Alfan Alketbi (IPH Alumna), PhD in public health



### What motivated you to pursue a PhD in Public Health, and how has your journey at the Institute of Public Health shaped your academic and professional goals?

My motivation to pursue a PhD in public health stems from a profound shift in life circumstances. Rejection from my dental profession, challenges in previous workplaces due to health conditions, and personal setbacks reshaped my path. Despite these hardships, my passion for improving community well-being and addressing health disparities remained unwavering. My time at the Institute of Public Health has been transformative, refining my research skills, enhancing critical thinking, and deepening my understanding of health equity and community engagement. I am dedicated to leveraging these experiences to make a meaningful impact on public health and contribute to creating healthier communities.

### Can you share a personal anecdote or experience that inspired your interest in public health research?

My sudden change in health condition, which led to a loss of skills necessary for my role as a dental clinician, felt like rejection at that stage of my life. However, this experience became a catalyst for a redirection towards public health. This shift allowed me to remain within the health field while exploring new avenues to contribute meaningfully. It reflects my resilience and adaptability in the face of challenges, ultimately leading me to pursue a career in public health research where I can make a positive impact.

### As a PhD student, what are some of the most valuable lessons you've learned during your time at the Institute of Public Health?

It's common to hear that research is an individual journey and that one must navigate it independently. However, the reality often involves a supportive and collaborative effort. At IPH, I found a second family in my research team, whose unwavering support made this journey possible. Their expertise, guidance, support, and encouragement were instrumental in overcoming challenges and achieving milestones. Together, we transformed what seemed like an impossible mission into a collaborative and impactful endeavor. It is "we" not "I".

### How do you balance your academic responsibilities with other aspects of your life, such as personal interests or community involvement?

Balancing academic responsibilities with personal interests and community involvement can be challenging, especially during a PhD journey. I faced difficulties, particularly with multiple breaks for physical rehabilitation abroad. However, I persevered and achieved a harmonious blend of academic rigor, personal fulfillment in the business field, and meaningful contributions to my community and field by being a founder, member, and treasurer for three years in EPHA. It required prioritization, effective time management, and seeking support when needed. Despite the challenges, finding enjoyment and fulfillment in the journey is crucial for long-term success and well-being.

### What do you believe sets your research approach apart, and how does it reflect your individual perspective within the field of public health?

My research approach stands out for its holistic and community-centered perspective on public health. I integrate qualitative and quantitative methods to understand health issues deeply, focusing on social determinants and cultural contexts. I prioritize health equity, collaboration with communities and policymakers, and ethical research practices, reflecting my commitment to social justice and making a meaningful impact on public health.

### Are there any particular mentors or role models at the Institute of Public Health who have significantly influenced your academic journey?

Prof. Michal at IPH is my role model, providing unwavering support and compassionate guidance throughout my academic journey. I remember our first meeting when he emphasized that my goal should not just be the title but centered around the children and their safety. He reiterated this sentiment at each subsequent meeting, reminding me of the high-value goal behind my research. This constant reinforcement motivated me to persevere and fight for this research despite facing logistical challenges. His belief in the importance of our work fueled my determination to make a meaningful impact in addressing children's safety issues. His understanding of my health challenges during my PhD was invaluable. Despite contemplating withdrawal multiple times, his compassion and encouragement inspired me to persevere and stay committed to my goals. Prof. Michal embodies the true meaning of nobility and humanity, and I am grateful for his mentorship and support throughout my academic journey.

### In what ways do you hope to make a meaningful impact in the field of public health through your research and future endeavors?

In the field of public health, particularly regarding school bullying in the UAE, I aim to make a meaningful impact through research and future endeavors in several key ways:

- 1. Conduct comprehensive research to understand the prevalence, causes, and consequences of school bullying in the UAE. This includes examining cultural and social factors that contribute to bullying behavior.
- 2. Use evidence-based approaches to develop and implement effective interventions to prevent and address school bullying. This may involve designing programs that promote positive school climates, teach conflict resolution skills, and foster student empathy and inclusivity.

- 3. We are collaborating with policymakers and education authorities to advocate for policy changes prioritizing bullying prevention and intervention strategies in schools. This includes promoting antibullying policies, establishing reporting mechanisms, and ensuring adequate support for victims and perpetrators.
- 4. Empower stakeholders such as educators, parents, guardians, and students with the knowledge and resources to recognize, report, and respond to bullying incidents effectively. This may involve training programs, workshops, and awareness campaigns to build a supportive and safe school environment.
- 5. Recognizing the impact of bullying on mental health, I aim to promote mental health literacy, resilience, and well-being among students. This includes offering counseling services, peer support groups, and promoting positive coping strategies.
- 6. Sharing research findings through publications, conferences, and community outreach to raise awareness, inform policies, and encourage collaborative efforts in addressing school bullying in the UAE and beyond.

By focusing on these areas, I want to contribute to creating inclusive, respectful, and safe learning environments where every student can thrive academically, emotionally, and socially.

### Can you describe a moment of personal growth or realization during your PhD studies, and how it has shaped your outlook on public health research?

During my PhD studies, I experienced a pivotal moment that reshaped my approach to public health research, particularly in the context of school bullying. Engaging with both students and policymakers was enlightening as it provided diverse perspectives on the issue. I realized the necessity of including students' experiences in my research, as they are at the heart of the bullying dynamics. Additionally, involving policymakers ensured that research findings could directly inform and influence policy decisions on bullying prevention and intervention strategies in schools.

To effectively capture these diverse perspectives, I adopted a mixed methods approach, combining qualitative insights from policymakers interviews with quantitative data from students surveys. This methodological approach allowed for a comprehensive understanding of the underlying factors contributing to bullying and the effectiveness of existing policies and interventions. This realization emphasized the importance of collaborative, community-centered research to promote health equity by addressing conformity-related issues and creating inclusive, safe student environments.

### What advice would you give to other aspiring researchers, particularly those interested in pursuing a career in public health?

For aspiring researchers interested in public health careers, my advice is to focus on building strong research skills and staying informed about current trends in the field. Networking and collaboration are essential, as they provide mentorship and practical experience opportunities. Aim to address real-world public health issues and communicate your findings effectively. Stay persistent and resilient, and prioritize ethical research practices to make a meaningful impact on public health.

### Looking ahead, what are your aspirations for the future, both within the realm of public health research and beyond?

As a school anti-bullying advocate and researcher, my aspirations for the future revolve around collaborating with stakeholders in the community to disseminate the findings and messages from my studies. I aim to bridge the gap between research and practical application by working closely with schools, parents, policymakers, and community organizations to implement evidence-based strategies that promote a culture of kindness, respect, and inclusion. By leveraging partnerships and engaging stakeholders in meaningful dialogue, I envision lasting positive changes in how bullying is addressed and prevented, ultimately fostering safer and healthier environments for children and adolescents.

#### Can you share tips for time management and productivity that you find useful?

I acknowledge that time management is an area I am actively working on improving. In the past, I have faced challenges with managing my time effectively, often leading to last-minute stress and juggling multiple tasks simultaneously. I understand the impact this has on my well-being and productivity, which is why I am committed to developing better time management skills. To address this, I have started implementing strategies such as prioritizing tasks based on urgency and importance. Breaking down larger tasks into smaller, manageable steps has also helped me stay focused and organized. Additionally, I am exploring time-blocking techniques to allocate dedicated time slots for specific tasks, reducing the tendency to procrastinate. I am also open to learning from others and seeking guidance on effective time management practices. I aim to enhance my productivity, reduce stress levels, and improve my overall health and performance by actively working on these skills.

Kamiar Aminian is Professor with the institute of Bioengineering and was the Director of the Laboratory of Movement Analysis and Measurement at EPFL. ## The Schools of Public Health and Social Participation in Health Systems Functioning - notes by ASPHER President Henrique Barros

Health challenges are ever-changing, and societies are evolving accordingly. Individuals increasingly ask for more intelligent, more comprehensive, and timelier decisions regarding the way health systems are structured, funding is decided, and human resources are trained.

Emerging issues related to the delivery of care as access to innovation may finally, on a daily basis, be more relevant than the concerns with emerging health threats. They are perceived as major turning points in the process of evaluation of health systems through the eyes of users. The perception of the functioning of health services and the extent of citizens' involvement in the whole process influences trust and consequently needs transformation. Every movement can be seen as a missed or gained opportunity for global improvement and a more person-centered, human-rights respectful way of dealing with citizen/patient-health professional encounters. To a certain extent, all this is mainly a question of health literacy. It has to do with the way health education and communication are handled in societies and how behavioral insights are perceived.

Thus, if we take this perspective, the central role of training health professionals, particularly the public health workforce, becomes clear. And we underline the public health professionals because they are pivotal in promoting health, designing and implementing preventive programs, and organizing the management of the different levels of care. And by doing it, public health has a most relevant role in defending the health care systems, as it leads to avoiding preventable situations while making the always limited resources available to face the more severe and demanding situations. Schools of Public Health, especially those organized as ASPHER members, play a fundamental role in responding to the need of well-trained and educated professionals. Training the workforce, valuing skills and competencies in health education and communication, influences directly and indirectly the health literacy capital of the communities and empowers individuals to make more rational choices. Particularly if children and youth are targeted so that sustainable life course gains are expected. ASPHER has been engaged in developing competency goals for public health professional training standards, in accrediting schools and programs through the work of APHEA, in building a professionalization roadmap, in close collaboration with WHO Europe, it is now 22 defining an ambitious core curriculum program, and looks at the organization of life long education schemes.Decades of work, we believe, contributed to technically prepare a strong public health European community able to respond to increasingly complex challenges. But it is time to recognize that new skills and new approaches are needed so that co-creation can be seen as a desirable and the public is actively present in public health decisions and evaluations - as true subjects and not mere objects of top-down actions. ASPHER is committed to leading such a process involving professionals and citizens in the organized community effort that defines public health and valuing both the knowledge and commitment of people in a truly solidary, shared global world.

### **VAX-ACTION: Tackling Effectively Vaccine Hesitancy in Europe**

VAX-ACTION, which is co-funded by EU4Health, aims to support EU Member States and relevant stakeholders to implement a combination of tailored, evidence-based interventions aimed to reduce vaccine hesitancy. It addresses the need to understand what type of interventions are now available, which are effective, how to translate effective interventions to new contexts, and to explain the unsuccessful ones to create opportunities for learning and redesign. VAX-ACTION is coordinated by IHMT, NOVA University Lisbon, PORTUGAL, under the lead of Prof Tiago Correia and builds on previous EU projects in the area.

### **EARLY: Evaluating, Identifying & Reducing Determinants MHC in Youth**

The EARLY project aims to reduce the burden of non-communicable diseases such as mental health conditions (MHC), especially depression, anxiety, stress disorders, and substance use disorders, and identify and reduce risky modifiable exposures for these conditions in youth. EARLY will pursue this goal by developing a comprehensive exposure matrix that can be adapted to emerging new risks. To understand youth, parents, and stakeholders' perceptions, we will conduct qualitative interviews by providing representative, multinational data on youth MHC and through developing, implementing, and evaluating a multicomponent intervention. This will serve as an innovative model for promoting mental health and preventing MHC. EARLY, which is co-funded through Horizon, is coordinated by the Technical University of Applied Sciences in Emden/Leer, GERMANY with Prof Jutta Lindert leading.

### **Enhancing European Public Health Preparedness, Pre-Hospital, and Disaster Medicine**

ASPHER is engaging in a new partnership for public health disaster preparedness with the World Association for Disaster and Emergency Medicine (WADEM) and the European Council for Disaster Medicine (ECDM). To initiate the collaboration, a special conference event was organized in Brussels on 25 March 2024 at the European Parliament. Global population growth, human migration, urbanization, climate change, conflict, and novel disease emergence present unprecedented challenges to public health worldwide. Enhanced curriculum development can assist practitioners of public health – both direct and in supportive roles – to better address dynamic and wicked problems threatening the public's health and welfare. The lessons of recent pandemics, warfare returning to the European continent, and population dislocation demand a fresh look at public health education and training.
